The Supreme Court lifted the ban that was imposed by.....[1] on all the entities governed by it, refraining them from dealing in virtual currencies. The Supreme Court bench which headed by Justice.....[2] and consists of Justice Ravinder Bhat and Justice V. Ramasubramanian analysed the powers of the .....[1] regarding the Virtual Currencies and what are Virtual Currencies.

It was argued before the court by Ashim Sood, counsel for the petitioners that.....[1] had no power to prohibit the trading activity in Virtual

Currencies as they are not legal tender but tradable commodities and do not fall within the regulatory framework of the it.

The Supreme Court after going through various explanations and definitions from different sources, observed that *"there is unanimity of opinion among all the regulators and the governments of various countries that though virtual currencies have not acquired the status of legal tender, they nevertheless constitute digital representations of value and that they are capable of functioning as (i) a medium of exchange and/or (ii) a unit of account and/or (iii) a store of value"*.

The apex court delved deeper looking into the definition of Currency as given under various Indian Acts and took into consideration various judgments from Courts to get clarity on the question that whether Virtual Currencies are just commodities. The judgment then went on to clarify that and said that the contention of petitioners that Virtual Currencies are commodities cannot be accepted.

While acknowledging the power of .....[1] to regulate the Virtual Currencies countermanded the Circular based on proportionality. The court said, *"When the consistent stand of .....[1] is that they have not banned VCs and when the Government of India is unable to take a call despite several committees coming up with several proposals including two draft bills, both of which advocated exactly opposite positions, it is not possible for us to hold that the impugned measure is proportionate"*

.....[1] Ltd, India's fifth largest private lender, was placed under moratorium by the central government after considering an application by the Reserve Bank of India (RBI). The RBI explained that in the absence of a credible revival plan, and in the interest of bank's depositors, it had no alternative but to apply to the Centre for imposing a moratorium on the private lender under Section 45 of the Banking Regulation Act, 1949. Accordingly, the central government imposed a moratorium effective from 6 pm on 5 March 2020 till 3 April 2020. ....[1] will not be allowed to pay depositors a sum exceeding Rs .....[2] lying in any savings, current or any other deposit account. During the review meeting chaired by Cabinet Secretary .....[1] the centre has decided to invoke Epidemic Act 1897 to ensure that multiple government advisories issued from time to time by the Ministry of Health and Family Welfare/State/UTs on COVID-19 become enforceable. In this regard, all the states and union territories (UTs) of India are advised to invoke the provisions of Section 2 of the Epidemic Disease Act 1897. Apart from this, **Disaster Management (DM) Act 2005** also invoked, and powers exercised by the home secretary.....[2] for being the Chairman of the **National Executive Committee (NEC)** under section 10 of the DM Act (2005) have been delegated to the Ministry of Health and Family welfare.

- Epidemic Act 1897 empowers the central government for prevention of the spread of "dangerous epidemic diseases". Now, its invocation will combat novel coronavirus in India.
- While section 2 of Epidemic Act 1897 includes special measures to be taken to prescribe regulations regarding the dangerous epidemic disease. It consists of detention of people or any vessel from international shores that are potent to spread the epidemic in the country.

The Act can be used to restrict the movement of suspected coronavirus patients to prevent further spread of the disease. The home ministry has prohibited cruise ships, crew, or passengers from coronavirus-hit nations to come to India till **March 31, 2020**, under the act. Starting from 13 March 2020, all existing visas, except diplomatic, official, UN/International Organizations, employment, project visas, stand suspended until **15 April 2020**.

The government nominated former **Chief Justice of India (CJI)** .....[1] , 65 years old, to Rajya Sabha. He was nominated by President of India Shri Ram Nath Kovind, under the exercise of the powers conferred by sub-clause (a) of clause (1) of **article.....[2]** of the Constitution of India, read with clause (3) of that article to the Council of States and to fill the vacancy caused due to the retirement of one of the nominated members. The notification of this effect was issued by the Ministry of Home Affairs.

He also headed the benches that ruled on matters like the entry of women in Sabarimala temple and Rafale fighter jet deal. He retired on November 17, 2019.

Justice .....[1] tenure as judge and CJI was marked by some controversies and personal allegations but that never came in the way of his judicial work that was reflected in the last few days when benches headed by him delivered some path-breaking judgments.

He etched his name in the annals of history when a five-judge bench headed by him on November 9 brought an end to the Ayodhya land dispute, which dates back to even before the Supreme Court came into existence in 1950.

However, his tenure in the Supreme Court will also be remembered for being part of a presser by the 'gang of four' senior-most judges in January 2018 which questioned the then CJI's way of functioning.

Later at a public function, Justice.....[1] had remarked that "independent judges and noisy journalists are democracy's first line of defence".

A "revolution, not reform" was needed to keep the institution of judiciary serviceable for the common man, he had said at the same function.

Justice .....[1] tenure as CJI was not free of controversy as he faced allegations of sexual harassment, of which he was cleared.

However, Justice..... [1] is more likely to be remembered for the Ayodhya verdict that gave Hindus the .....[3] acre disputed land for construction of Ram Temple, and order that Muslims be given a 5-acre land at a "prominent location" to build a mosque in the city.

Japan 's Prime Minister (PM).....[1] and the President of the International Olympic Committee (IOC) .....[2] have agreed to postpone the **Tokyo 2020 Olympic Games** for a year due to the worldwide coronavirus pandemic. Now the Tokyo Olympics, which is scheduled on July 24 – August 9, 2020 will take place in **2021** and the new dates will be announced later. This is the first time in the Olympics' 124-year history that it has been postponed due to virus, because earlier the Olympic Games have been cancelled only because of world war.

In the present circumstances and based on the information provided by the WHO today, the IOC President and the Prime Minister of Japan have concluded that the Games of the XXXII Olympiad in Tokyo must be rescheduled to a date beyond 2020 but not later than summer 2021, to safeguard the health of the athletes, everybody involved in the Olympic Games and the international community," the IOC said in a statement.

"The leaders agreed that the Olympic Games in Tokyo could stand as a beacon of hope to the world during these troubled times and that the Olympic flame could become the light at the end of the tunnel in which the world finds itself at present. Therefore, it was agreed that the Olympic flame will stay in Japan. It was also agreed that the Games will keep the name Olympic and Paralympic Games Tokyo 2020."
